

# The Union Bank Company Kasasa Qualification Calendar



- Have at least 12 Check Card purchases post and clear your account within the monthly qualification cycle.
- Receive monthly e-statements.
- Have 1 direct deposit or 1 monthly auto debit post and clear each monthly qualification cycle.

To earn the Kasasa Cash interest and ATM refunds, you must meet all three qualifications by 5:00 PM EST one day prior to your statement cycle ending date. This is referred to as your Qualification Date. Transactions posted to your account after 5:00 PM EST on the Qualification Date will count towards meeting the Kasasa qualifications for the next month's qualification cycle. The Qualification Dates are reflected in the calendar below as a green day with a box around the date.

**Qualification Date**

Interest and ATM fee refunds (if your account qualifies) will be automatically deposited to your account on the statement cycle end date.

The dates for interest payments and ATM fee refunds are reflected below by a blue day with a circle around the date.

If you have a Kasasa Saver account, your interest and ATM fee refunds will be transferred to your savings account on the day following the statement cycle end date.

The dates for these transfers are reflected below by an orange day with a triangle around the date.
